# Pink Dolphin Campaign



#### Objective

Taiwan Pink Dolphins are found in the shallow coastal waters between Miaoli and Tainan. They are a critically endangered and on the IUCN "Red List".

There are several major threats to their survival, including by-catch, industrial activity, freshwater extraction and diversion in river systems, pollution and noise disturbance. A recent threat to the dolphins has been the possibility of the construction of a petrochemical plant on Dachen coastal wetlands. The area is an important habitat for the dolphins It is one which local residents, in particular oyster farmers, consider would have been disastrous for the diverse wetland ecology found there, had construction been allowed to go ahead. To combat the threat a locally based conservation organization headed by a Dr. Tsai launched a campaign to sell 'shares' in 2000ha of the land to the public.

The campaign's aims were to block the proposed development and to then set up a trust to manage the mudflats for its long term protection

### Approach

The trust encouraged the public to "buy a patch of the wetlands and save the pink dolphins" and to then entrust it to be sustainably managed by a conservation group.

This was Taiwan's first environmental driven campaign, calling out for a collective purchase of the land at risk, giving a voice to the public's concerns. The campaign was supported by a planned set of concrete actions to advance the collective agenda. They were undertaken to demonstrate that the wetlands generate ecological and economic benefits that support the livelihood of both human and other life forms.

These activities included:

- a series of campaign events,
- press conferences,
- targeted protests, and
- lobbying.
